### 1. WHAT INFORMATION WE COLLECT AND WHY

#### Personal Information you give us:

fractional-expert collects and processes the following information: user's (customer's) full name, postal address, email, and telephone number. We only collect data that you voluntarily give us. For example, we may collect Personal Information (data from your public social network profile) to receive feedback from you about our services or request information about your location to register on the website to provide services or participation in promotions. You have the right not to provide us with this information, but in this case, our website and services may not work correctly, or some of their functionality will be unavailable for you.

Moreover, we may receive certain information from you automatically while you are using the website. Such information may include your IP address, information about the operating system of your computer/mobile device and the type of browser, the type of your device, the unique device identifier (UDID) or mobile equipment identifier (MEID) of your mobile device, the address of the website on which a link to us was posted and information about the pages you visited on our website.

We may use this information to operate, maintain and customize our website and services. In this Privacy Policy, we also provide additional information on how we use cookies. Mobile devices and location information

The mobile versions of our websites can receive information about the exact location of a mobile device using GPS, Wi-Fi, Bluetooth technology, or taking into account the distance to the nearest mobile base station with your separate consent.

fractional-expert uses this information to provide services based on your location, for example, when looking for live events in your country and your city or identifying special offers for residents of your region that you may be interested in or personalizing your interaction with fractional-expert.

You may always revoke a consent that you have provided to determine your location by turning off the collection of location data in your device or browser settings. If you would like to disable the location service on your mobile device, we recommend contacting your mobile service provider or mobile device manufacturer. Please note that after deleting the specified data, some services may not work correctly.

# 2. METHOD AND LOCATION OF PERSONAL INFORMATION PROCESSING

**Processing Method** 

Processing of Personal Information is carried out using computers and(or) automation tools under procedures and methods that meet data collection purposes.

In some cases, the collected Personal Information may be available to certain categories of fractional-expert responsible people (Data Operator) related to the operation of the website (such as administration, sales, marketing, call center, legal department, system administrators) or third parties (such as external technical service providers, postal organizations, hosting service providers, information technology companies, communication services) to whom we entrust to act as a Data Processor if necessary. You can additionally request the list of these people from us.

Location of Personal Information processing

### 3. USE OF PERSONAL INFORMATION

We may also ask you if you would like to receive marketing materials from our business partners. If you agree to a newsletter subscription, we

will not share your Personal Information with these partners but email you materials on behalf of these partners.

fractional-expert reserves the right to use and disclose any information about you, in cases explicitly stated by law or other regulation, to protect the integrity of our services, protect our rights, or assist law enforcement agencies in investigating crimes and ensuring public safety.

### 4. PROTECTION OF PERSONAL INFORMATION

fractional-expert takes all commercially reasonable measures to prevent unauthorized access to Personal Information and data obtained while using the fractional-expert website or services. We are trying to protect your Personal Information, but we encourage you to take all available precautions to protect your Personal Information during its transfer. To do this, change passwords more often, use combinations of letters and numbers, and use a secure browser.

Ensuring the information security for children

### 5. ACCESS TO INFORMATION

You have complete control over all Personal Information you provide us. # 6. COOKIES, WEB BEACONS, AND OTHER TECHNOLOGIES

https://fractional-expert.com/ website collects information about your behavior on our website and visits to the pages of the website to obtain statistics of visits and the effectiveness of using the site, personalize and adapt our services to the interests of each user. We do this using a variety of technologies, one of which is cookies. It is data that a website can send to your browser, and it will be stored on your computer for later identification by the website.

We use persistent cookies to store information such as the language and country of a user.

If you do not want to receive cookies or if you would like to be informed about the cookies receipt, please configure your web browser. However, if you disable all cookies, you may not be able to use some of the services and features of the website.

### 7. TARGETED ADVERTISING

We use cookies, Google Tag Manager, Facebook Pixel, and other advertising technologies to serve you advertisements based on your personal interests and preferences. This Item of our Privacy Policy provides additional information on this matter.
